## Technical Assistance and Capacity Building

#### Innovative Finance and Asset Concessions

- Helping project sponsors identify publicly owned, underutilized assets with potential to generate revenue or economic development
- Increasing local capacity to use innovative financing and project delivery tools, and form strong partnerships with the private sector

### Regional Infrastructure Accelerators

- Building capacity at local level to incubate good projects and accelerate delivery through innovative approaches
- Assistance for project planning, studies and analysis, revenue forecasting, preliminary engineering and design, and statutory and regulatory compliance analyses

#### Rural and Tribal Assistance

## Rural and Tribal Assistance Pilot Program (RTA)

Five-year pilot program that funds financial, technical, and legal assistance to states and rural and tribal communities.

### Now Available: \$54.2 million

- \$20 million for Tribal applicants
- No local match required



Grants are first-come, first-served, with a simplified application beginning September 8 at 2:00p.m. ET until October 8 at 11:59p.m. ET.

### RTA Grant Eligibility – Local Governments

- Federally recognized Indian Tribes

- Town, township, parish, city, borough, county
- Local public authority (including transit agency)
- Special district
- School district
- Council of governments, planning district commission, metropolitan planning organization, rural planning organization



### RTA Grant Eligibility – State Governments

### **Eligible Applicant**

- Local government or State government on behalf of a project—
  - Not in a Census Bureau 2020designated urban area.
    - --OR--
  - In a Census Bureau 2020-designated urban area with a population of 150,000 or less.
- Federally recognized Indian Tribes
- Department of Hawaiian Home Lands

### In addition to the 50 states, includes:

- Puerto Rico
- U.S. Virgin Islands
- Guam
- American Samoa
- Northern Mariana Islands

### RTA Grant Eligibility – Federally Recognized Indian Tribes

### **Eligible Applicant**

- Local government or State government on behalf of a project—
  - Not in a Census Bureau 2020designated urban area.
    - --OR--
  - In a Census Bureau 2020-designated urban area with a population of 150,000 or less.
- Federally Recognized Indian Tribes
- Department of Hawaiian Home Lands

### RTA Grant Eligibility - Projects


### Sample Categories of Projects

- Highway projects, bridges, and tunnels
- Public transportation projects
- Freight rail projects
- Airport projects
- Wildlife crossing projects
- Highway-railway grade crossing or grade separation
- Surface transportation project within the boundaries or functionally connected to an international border crossing that improves a facility owned by Federal, State, or local government

Projects should be reasonably expected to be eligible under the eligible projects listed above.

### Round 1 Awards - Project Types

- Roadway
  - New road alignment (2)
  - Roadway safety improvements
  - Traffic impact analysis
  - Secondary evacuation route
- Bridge
  - New bridge
- Pedestrian
  - Separated pedestrian pathway and lighting
  - Trail connection
- Transit
  - Transit feasibility study
- Maritime
  - Port development (3)





### Notice of Funding Opportunity Amendments

Changes made to this NOFO from the previously amended NOFO include:

- Increasing program funding from \$27 million to \$54.2 million
- Increasing funding minimum of individual awards from \$200,000 to \$250,000
- Increasing funding maximum of individual awards from \$750,000 to \$2,500,000
- Increasing tribal set aside from \$10 million to \$20 million
- Eliminating the "Multi-Community" grant type

  - Word limits for most narrative questions
