AIR CARRIER GROUPINGS

This Accounting and Reporting Directive updates the reporting groups for filing the Form 41 report during calendar year 2020 and replaces Reporting Directive No. 328. From our review, the reporting carrier groupings for the carriers below are updated as indicated:

AIR CARRIER: NEW REPORTING GROUP:

Elite Airways Group I - \$20 million to \$100 million to Group II

Kalitta Air Group II to Group III

Lynden Air Cargo Group I - \$20 million to \$100 million to Group II

Rhoades Group I - under \$20 million *to* Group I - \$20 million to \$100 million Xtra Airways Group I - \$20 million to \$100 million *to* Group I - under \$20 million

Carriers are grouped according to the operating revenue boundaries contained in Section 04 of Part 241. The current reporting levels are:

Group III Over \$1 billion;

Group II Over \$100 million to \$1 billion;

Group I \$100 million and under,

Subgroups:

Group I - \$20 million to \$100 million,

Group I - Under \$20 million.
