Speaker Biographies

Bryan Baszczewski

Bryan Baszczewski is a Senior Operations Research Analyst in the Strategic Analysis and Benchmarking Group within the FAA's Air Traffic Organization. He currently develops future demand scenarios for investment analysis and strategic planning purposes. Prior to joining the FAA in 2009, he supported the Operations Research group within the office of Investment Analysis. Mr. Baszczewski graduated with a Bachelor of Science in Management Science and Information System from Pennsylvania State University.

Jonathan Foglia

Jonathon Foglia is a Washington, D.C. based member of Cozen O'Conner. He routinely represents airlines and other aviation entities before the DOT, FAA, CBP, and TSA, and advises on a range of regulatory matters, including compliance with DOT's aviation consumer protection requirements. Mr. Foglia also is on the adjunct faculty at Georgetown University Law Center, where he has taught aviation law for the past seven years. He is active in the ABA Forum on Air & Space Law and currently serves as Editor-in-Chief for the Forum's quarterly publication, The Air & Space Lawyer. Since 2017, Matthew du Mee has served as the Consumer Litigation Unit Chief under Arizona Attorney General Mark Brnovich.
