Heather L. Ansley

Heather L. Ansley is the Associate Executive Director of Government Relations at Paralyzed Veterans of America (PVA). Her responsibilities include managing the organization's efforts on Capitol Hill and working with the Administration to promote legislation and policies that ensure veterans with catastrophic disabilities receive the health care and benefits that they have earned and the civil rights protections that they deserve. She also works to promote collaboration between disability organizations and veterans service organizations and currently serves as the Immediate Past Chair of the Consortium for Citizens with Disabilities and on the board of the Disability Rights Bar Association. Ms. Ansley holds a BA and MSW from the University of Missouri-Columbia and a JD from the Washburn University School of Law in Kansas.

Peter Axelson

Peter W. Axelson is Founder and Director of Research and Development of Beneficial Designs, Inc., a rehabilitation engineering design firm that works towards universal access through research, design, and education. Peter has a passion for aviation with almost 3 million miles of commercial air travel. He has also logged over 2,400 hours as an instrument rated pilot flying with hand controls. In a research project supported by the PVA Research Foundation, his company conducted testing with 56 manual and powered wheelchair users to evaluate different boarding wheelchairs and to evaluate transfer technologies. The project also surveyed 695 nonambulatory air travelers to explore a variety of issues related to commercial air travel. As a result of this research project, Peter started the RESNA Assistive Technologies for Air Travel standards committee. As a result of serving on the U.S. Access Board Recreation Access Advisory Committee, he was able to guide the development of universal access guidelines for sidewalks, trails, ski areas, amusement parks, playgrounds, and other outdoor recreation environments. Peter is a regular guest lecturer in the Perspectives in Assistive Technology course at Stanford University where he earned bachelor's and master's degrees in mechanical engineering and product design after he was paralyzed during training at the USAF Academy.

Kelly Buckland

Kelly Buckland is a person with a disability who has been actively involved in disability issues since 1979. Kelly graduated from Boise State University with a B.A. in Social Work and Summa Cum Laude from Drake University with a Masters in Rehabilitation Counseling. In recent years, Kelly has been honored with numerous state and national awards. He has testified before Congress numerous times on issues such as universal health care, Fair Housing, appropriations for centers for independent living, Olmstead and COVID 19. He has been closely involved with the direct-service and systemic change aspects of the disability rights movement. Additionally, Kelly has a long history with the National Council on Independent Living (NCIL). He served on the NCIL Governing Board from 1998 until 2021, as NCIL Vice-President from 2001-2005, and as NCIL President from 2005 to 2009. And as the Executive Director from 2009 until 2021.

Graham Keithley

Emily Voorde serves as the Biden Administration's White House Associate Director of Disability Outreach in the Office of Public Engagement. She was born with Osteogenesis Imperfecta and is a wheelchair user. Much of her work in the White House is ensuring that space is carved out for voices of persons with disabilities across policy issues. Among her many roles is soliciting input from multiple-marginalized populations through Listening Sessions, partnering with Agencies to ensure that policy reaches stakeholders, and recommending opportunities for the President, First Lady, Vice President, and Second Gentleman to engage with the disability community in meaningful ways.
