## A Message from Dr. Willie Smith, Senior Procurement Executive

By some calculations, small businesses generate more than 40% of the U.S. economic activity. Recognizing that small businesses are the lifeblood of the U.S. economy, a key part of the mission of the [Office of the Senior Procurement Executive](#)

(through the activities of nearly 500 contracting officers and contracting specialists across the Department) is to ensure that our procurement practices continue to support the creation of new jobs - while at the same time help the Department benefit from the innovation and competitiveness that drive our economy.

With more than \$8 billion in federal-direct contracting, (and policy and oversight for billions more), OSPE continues to push actively toward the Administration's and the Department's priorities in areas of safety, infrastructure, climate, and diversity. ## OSDBU Celebrates Women's History Month with 3rd Annual Event

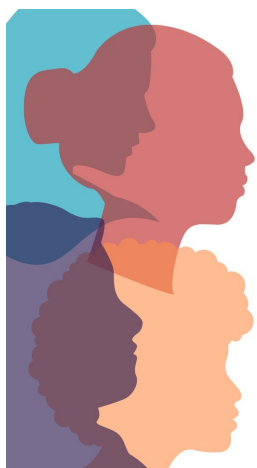
On March 15, in observance of Women's History Month, the Office of Small and Disadvantaged Business Utilization (OSDBU) hosted the [3rd Annual Women's Wednesday for Small Business and Matchmaking Event](#). This event was also planned in alignment with the federal mandate to award at least five percent of U.S. Department of Transportation procurement dollars to Women-Owned Small Businesses.

Panelists were given the opportunity to hear from not only U.S. Department of Transportation Secretary Pete Buttigieg and Deputy Secretary Polly Trottenberg, but our operating administrations (FAA, FHWA, OST), partner agencies (MBDA, GSA, DOE), various banking institutions and small business investment capital funds, and some of our internal USDOT programs. Additionally, firms were given the opportunity to hear from The Elocen Group, a minority woman-owned small business who has had great success contracting with the U.S. Department of Transportation.

Brittany Young, Small Business Specialist and Women-Owned Small Business Advocate, spearheaded the event in coordination with the OSDBU team with the goal of providing women-owned small business opportunities — ranging from capacity building resources, access to capital, best practices, and upcoming contracting opportunities, including Bipartisan Infrastructure Law-related projects.

## Small Business Leverages Strengths and Expands During Pandemic

Doreen Blades, President and CEO of US Eco Products Corporation, founded in 2009, is a full-service government contractor, logistics, and fulfillment solution provider of sustainable green products and sanitation services. In addition, the company works as a wholesaler of chemical and related products, providing maintenance and cleaning products to companies, colleges, universities, states, airports, airlines, restaurants, and federal agencies.

Ms. Blades is certified as an 8(a), Women-Owned Small Business (WOSB), Economically Disadvantaged Women-Owned Small Business (EDWOSB) and an Airport Concession Disadvantaged Business

Enterprise (ACDBE). The business is also certified by NY/NJ Port Authority as a Disadvantaged Business Enterprise (DBE) and Women Business Enterprise (WBE) for the Northeast Region as well as a certified HUBZone company in the gateway city of Haverhill, MA.

Ms. Blades came to Northeast Small Business Transportation Resource Center (SBTRC) in 2017 to obtain technical assistance for certification as a DBE starting her business in her home state of Massachusetts and subsequently continued to expand her DBE certifications to all 50 states. The Northeast SBTRC helped her obtain these certifications and identified various projects and state and federal contract opportunities at various transportation agencies. As a result, this business has capitalized on these certifications. Doreen Blades was named Top CEO WBE's of 2017 by WEUSA and the WBE star of 2016 by WBENC and Awarded SBA New England Region Prime Contractor of the Year 2022.

"Northeast SBTRC has been a valued resource in the Eco-Products Corporation journey over the past several years, particularly in helping the company leverage its strengths despite many perceived disadvantages," said Blades.

Due to the nature of US Eco Product Corporation and the need for sanitized products due to the Covid-19 impact, her business achieved a more significant number of contracts at the federal level. As a result, a company that used to generate approximately \$200,000 (2018) in annual revenue reported over \$2.1 million from new state and federal contracts by the end of 2022. Ms. Blades received contracts for pier building materials from a local construction company (B Robert Our Co.), supplying ice melt to the Columbus Ohio Airport, and catering supplies to Sodexo for Alaskan Airlines in Seattle and Portland airports. In 2020 US Eco Products supplied LaGuardia Gateway Partners and Virginia Department of Transportation with COVID supplies, and in 2023 provided NYC Department of Transportation with snow blowers.

## USDOT Gulf SBTRC Hosts Small Business Contracting Symposium in Irving, TX

The USDOT Office of Small and Disadvantaged Business Utilization (OSDBU) and its Small Business Transportation Resource Centers (SBTRCs) continue to partner to host our regional Small Business Contracting Symposiums. They are put on in collaboration with the US Small Business Administration (SBA) and Minority Business Development Agency (MBDA) within US Department of Commerce. These regional symposiums provide small businesses information and resources related to upcoming contracting opportunities generated at the federal and state levels from the recently passed [Bipartisan Infrastructure Law \(BIL\)](#).

On March 8, the [USDOT Gulf SBTRC](#) with support from the North Texas Conference of Minority Transportation Officials (COMTO), hosted a regional symposium in Irving, TX. The event also livestreamed for audiences in Louisiana, New Mexico, Oklahoma, and Texas. The U.S. Secretary of Transportation, Pete Buttigieg delivered opening remarks via pre-recorded video, and U.S. Department of Commerce MBDA Undersecretary, Donald Cravins Jr. participated virtually to share live remarks to symposium attendees. SBA Region IV Administrator, Ted James, and Dallas Area Rapid Transit President and CEO, Nadine Lee participated as featured morning speakers. In the afternoon, Region 6 FTA Administrator, Gail Lyssy and Dallas-Fort Worth Airport Vice President of Planning, Smitha Radhakrishnan participated as keynote speakers. Other panelists and representatives in attendance included MBDA, SBA, State DOTs, capital providers, and prime contractors. Special thanks to Jeri Bird, FAA Small Business Advocate, for her support of the event!

Additionally, the Gulf SBTRC hosted a dynamic [Women In Transportation Initiative \(WITI\) Program](#) event, “Aviation Careers & World of Drones.” Two local area schools of young girls from middle and high schools participated in the event to learn about transportation careers and opportunities to engage in transportation-related initiatives from a variety of professionals.

Upcoming Funding Opportunities & Technical Assistance

## Become a USDOT SBTRC Grantee in the Central Region

In April, the Notice of Funding Opportunity (NOFO) for the Central Region Small Business Transportation Resource Center (SBTRC) will be released on [Grants.gov](https://www.grants.gov) for prospective applicants interested in becoming a grantee for the USDOT SBTRC in the Central Region which covers the states of Arkansas, Iowa, Kansas, Mississippi, and Missouri. Learn more about the opportunity from a recorded [information session](#) held on January 11, 2023 as a resource for prospective applicants. Business-centered community-based organizations, transportation-related trade associations, colleges and universities, community colleges, or chambers of commerce, registered with the Internal Revenue Service as 501 C(6) or 501 C(3) tax-exempt organizations can compete for this funding.



### More About Our Small Business Transportation Resource Centers

The USDOT OSDBU established the [SBTRCs](#) as a network of grantees across the country, and these centers work closely with the transportation contracting community and other technical assistance providers to serve small and disadvantaged, transportation-related businesses. These centers provide technical assistance to small and disadvantaged businesses to build their capacity in order to become more competitive when bidding on USDOT procurement opportunities and federally-funded contracts.



## Non-Federal Funding & Technical Assistance Opportunities

USDOT is part of the interagency [Thriving Communities Network](#), a partnership between Federal agencies intended to align and coordinate our technical assistance resources to help communities thrive.

The U.S. Department of Housing and Urban Development (HUD) opened the portal for local governments to request technical assistance for its [Thriving Communities technical assistance \(TCTA\) program](#). This funding will help local governments which received federal transportation funding ensure housing needs are considered as part of their larger infrastructure investment plans, with a focus on disadvantaged communities. Local governments can request technical assistance using [this form](#). Requests are reviewed on a rolling basis starting March 15, 2023.

\$70 million in funding is available through the [Environmental Justice Government-to-Government \(EJG2G\) Program](#), which provides funding to support government activities that lead to measurable environmental or public health impacts in communities disproportionately burdened by harms. \$30 million is also available through the [Environmental Justice Collaborative Problem-Solving Cooperative Agreement \(EJCPS\) Program](#), which provides financial assistance working to address local environmental or public health issues in their communities.
