

NEW MEXICO 2045 FREIGHT PLAN:
FREIGHT INVESTMENT PLAN
Amendment 1
July 21, 2023

Introduction

In compliance with Federal Highway Administration (FHWA) guidance for state freight plans under the Infrastructure Investment and Job Act (Public Law 117-58) and related federal guidance, the New Mexico Department of Transportation (NMDOT) is requesting to amend the current Freight Investment Plan (FIP), originally presented as Table 32 on pages 113 and 114 of the New Mexico 2045 Freight Plan (March 17, 2023). FIP Amendment 1 below would replace and supersede the current FIP contained in the New Mexico 2045 Freight Plan document. FIP Amendment 1 would also align the FIP with the upcoming State Transportation Improvement (STIP) two-year update. This amendment incorporates four inter-related actions.

Action #1

The first action is to update the National Highway Freight Program (NHFP) with revised funding targets. In program year FFY 2024 NMDOT anticipates receiving \$13.37 million in NHFP funds. This target slightly increases in program year FFY 2025 to \$13.64. In program years FFY 2026 and FFY 2027 NMDOT anticipates receiving \$13.91 million per year in NHFP funding. This change in anticipated NHFP funding targets is summarized in the table below.

Action #2

The second action relates to Project 3 - LC00330 (I-10 Bridges) that was included in the original Freight Investment Plan. Project LC00330 will now be funded with HIBR (Highway Infra Bridge Replace) funds. Accordingly, NMDOT is requesting to remove LC00330 from the FFY 2025 NHFP program year and replace it with Project A301001 (NM 500 Rio Bravo Bridge Replacement) for FIP Project 3. This action is summarized in the tables below.

Action #3

The third action relates to unanticipated budget shortfalls regarding project S100400 (NM 466 St. Michaels) that was included in the original Freight Investment Plan. For the FIP to remain fiscally constrained, NMDOT is requesting to remove Project 4 - S100440 (NM 466 St. Michaels) from the FFY 2026 NHFP program year and replace it with E100322 (NM 213/NM 404 interchange improvements) for FIP Project 4. This action is summarized in the tables below.

All the proposed replacement projects above, A301001 (NM 500 Rio Bravo Bridge Replacement), E100322 (NM 213/NM 404 interchange improvements), and F100342 (US 550 Pavement Rehab Phase II) are currently on schedule and are on the National Highway Freight Network and therefore eligible for National Highway Freight Program funding. These actions ensure that the Freight Investment Plan remains fiscally constrained. This amendment request is also consistent with the over-arching programming guidance that was received from the Freight Advisory Committee (FAC) as part of the freight planning process to maximize the amount of NHFP funding each program year for New Mexico.

The combined results of these actions are detailed below as Freight Investment Plan Amendment 1. FIP Amendment 1 replaces and supersedes the Freight Investment Plan within the New Mexico 2045 Freight Plan document and be posted to our website.
