Speaker Biographies



Pete Buttigieg

U.S. Secretary of Transportation

Pete Buttigieg serves as the 19th Secretary of Transportation, having been sworn in on February 3, 2021.

His focus as Secretary is to deliver the world's leading transportation system for the American people and economy. He has worked to achieve organizational excellence in the department's operations, and to focus the department on five policy goals: safety, jobs, equity, climate, and innovation. In his first year at the Department, he prioritized supporting the development and passage of President Biden's signature Bipartisan Infrastructure Law. Since the law's passage, Secretary Buttigieg and his team have focused on effectively delivering the investments

provided by this legislation, enabling the most significant improvements in U.S. transportation infrastructure in over half a century.

The Secretary has also focused on intervening to support American supply chains dealing with shockwaves from the pandemic, including measures to help cut in half the long-dwelling container congestion at America's largest ports. Other major initiatives in his early tenure have included a comprehensive national roadway safety strategy to reduce deaths and serious injuries; delivery of emergency COVID-19 relief funds to transit agencies across America; and awards of over \$9.5 billion in discretionary funding to enhance transportation through over 800 projects in communities across America.

The first openly gay person confirmed to serve in a president's Cabinet, Secretary Buttigieg previously served two terms as mayor of his hometown, South Bend, Indiana, where he worked across the aisle to transform the city's future. Household income grew, poverty fell, and unemployment was cut in half. His work on transportation as mayor was nationally recognized, including an award for innovative streetscape design from the U.S. Department of Transportation where he now serves.

He also served for seven years as an officer in the U.S. Navy Reserve, taking a leave of absence from the mayor's office for a deployment to Afghanistan in 2014.



Danielle Arigoni

Managing Director of Policy and Solutions, National Housing Trust

Danielle Arigoni is an urban planner and community resilience expert. She currently serves as Managing Director for Policy and Solutions at National Housing Trust, where she provides strategic direction for the organization's sustainability and resilience policy efforts, oversight and guidance for NHT's state and local advisory services, and leadership for NHT's fundraising and communications teams. She is also author of Climate Resilience for an Aging Nation (Island Press, October 2023) which explores the impacts of climate change on a rapidly growing demographic – people over 65 – and the need for community-scale solutions to reduce risk for all. Danielle holds a master's degree in City and Regional Planning from Cornell University, and

serves as a Board Member for the League of American Bicyclists and Smart Growth America.



Shailen Bhatt

Administrator, Federal Highway Administration

On January 13, 2023, Shailen Bhatt was sworn in by U.S. Transportation Secretary Pete Buttigieg as the 21st Administrator of the Federal Highway Administration (FHWA). In this role he oversees over 2,700 FHWA employees in all 50 States, U.S. Territories, and the District of Columbia, and provides executive leadership on strategic initiatives and policy. Bhatt brings a record of successful project and program delivery needed in this once-in-a-generation level of infrastructure investment in which the impacts of FHWA policy and funding choices will last for generations, and will make people safer, reduce the emissions in our air while implementing resilient transportation systems for our changing climate, create a fairer

transportation system, and strengthen our economy. Bhatt graduated summa cum laude from Western Kentucky University with a degree in Economics.



Christopher Coes

Assistant Secretary for Transportation Policy, U.S. Department of Transportation

Christopher Coes serves as the Assistant Secretary for Transportation Policy in the Office of the Assistant Secretary for Transportation Policy. Coes previously served as Vice President for Land Use and Development at Smart Growth America (SGA), Senior Fellow at the Brookings Institute, Professor at George Washington University, and Deputy Director and Senior Advisor for the Transportation for America campaign. Coes earned a Bachelor of Arts and Master of Arts in politics and government from St. John's University



Dr. Morteza Farajian

Executive Director, Build America Bureau, U.S. Department of Transportation

Dr. Morteza Farajian has served as a senior executive leading the Build America Bureau at USDOT (the Bureau) since April 2019. He is responsible for credit programs and loan guarantees with \$29 billion in the existing portfolio and more than \$22 billion allocated, issued or pending in private activity bonds that support development of large-scale and multimodal transportation infrastructure. The Bureau also promotes innovative project financing solutions and helps state and local governments develop and finance Public-Private Partnership (P3) transactions for transportation facilities. Prior to this position, Dr. Farajian served as acting Deputy Secretary of Transportation and Director of Public-Private Partnerships (P3) Office in

Virginia. He received his Ph.D. and M.Sc. degrees in Project Management from the University of Maryland. He also has a B.S. degree in Civil Engineering.

Raffi Freedman-Gurspan,

Deputy Director of Office of Public Engagement, U.S. Department of Transportation

Raffi Freedman-Gurspan is the Deputy Director of Public Engagement at the United States Department of Transportation. She was previously a Deputy States Director for the All on The Line campaign of the National Redistricting Action Fund and oversaw work in the Midwest and East Coast. Raffi also has extensive experience in LGBTQ and gender justice community advocacy. Her experience includes serving as Director of External Relations at the National Center for Transgender Equality and Senior Associate Director for Public Engagement, and Outreach and Recruitment Director for Presidential Personnel at the White House during the Obama Administration, where she was the first openly transgender staffer in history to work



Stephanie Gidigbi Jenkins

Vice President of Strategy, Communities First Fund

Stephanie Gidigbi Jenkins champions public policy solutions that promote economic, social, cultural, and environmental benefits for communities. She is a 2022 Open Society Foundation Leadership in Government Fellow and former public official who applies a transformative justice approach to public infrastructure investment. As a social entrepreneur and partner at North Star Strategies, Stephanie co-envisioned the Communities First Infrastructure Alliance to advance community-centered plans, racial equity practices, and climate resilience principles, serving as Vice President of Strategies. She fosters strategic partnerships to advance federal campaigns, coalition efforts, racial equity, cultural resilience, and climate

justice.



Ariel Gold

Senior Policy Analyst, Office of the Under Secretary for Transportation Policy, U.S. Department of Transportation

Ariel Gold is a Senior Policy Analyst in the Office of the Undersecretary for Transportation Policy of the U.S. Department of Transportation (USDOT). In this capacity, she drives development and implementation of policies and programs to advance transportation equity, accessibility, and innovation, including the Department's Equity Action Plan and Disability Policy Priorities. She serves as a member of the Department's Equity Management Team, working to institutionalize equity Department-wide through the Secretary's Equity Council. Prior to joining USDOT, Ariel managed the open data program at Amazon Web Services (AWS)

and led the launch of public data projects in partnership with organizations such as the U.S. National Oceanic and Atmospheric Administration (NOAA) and International Computer Science Institute (ICSI).



Monica Guerra

Community Solutions Technical Assistance Lead, U.S. Department of Transportation

Dr. Monica Guerra is the Community Solutions Technical Assistance Lead at the Department of Transportation. She brings an extensive background leading technical assistance, research and planning efforts for diverse public, private, and non-profit partners. Mostly recently, she has work in California, advising local governments on opportunities to align housing, public health, climate change, and economic inclusion strategies to advance comprehensive community development investments and policies.



Mitch Landrieu

Senior Advisor to the President and White House Infrastructure Coordinator

Mitch Landrieu serves as Senior Advisor to the President and White House Infrastructure Coordinator where he is responsible for coordinating the implementation of the historic Bipartisan Infrastructure Law, including the most significant and comprehensive investments in roads, bridges, rail, transit, ports, airports, safe water, clean energy, and high-speed internet in generations.

Landrieu served as the 61st Mayor of New Orleans from 2010 to 2018. When he took office, the city was still recovering from Hurricane Katrina and in the midst of the BP Oil Spill. He

kick-started the city's recovery by fast-tracking over 100 projects and securing billions in federal funding for schools, hospitals, parks and critical infrastructure. In 2015, Landrieu was named "Public Official of the Year" by Governing, and in 2016 was voted "America's top turnaround mayor" in a Politico survey of mayors. He also served as President of the U.S. Conference of Mayors.



Jeffrey Lubell

Principal Associate for Housing and Asset Building, Abt Associates

Jeffrey Lubell is a Principal Associate for Housing and Asset Building at Abt Associates where he oversees and provides senior-level guidance on a range of projects related to affordable housing, financial capability, asset-building, and community development. Among other topics, he has a particular interest in the intersection of housing and other policy domains, including health, education, transportation, energy and the environment. From 2006 through August 2013, Mr. Lubell was the Executive Director of the Center for Housing Policy, a nonprofit research organization affiliated with the National Housing Conference. He has also served as Director of the Policy Development Division in HUD's Office of Policy Development

and Research, as a housing policy associate at the Center on Budget and Policy Priorities, and as an independent consultant.



Irene Marion

Director, Departmental Office of Civil Rights, U.S. Department of Transportation

Irene Marion serves as the Director of the Departmental Office of Civil Rights. As leader of the Departmental Office of Civil Rights, Director Marion oversees USDOT's enforcement of civil rights laws and regulations, which prohibit workplace discrimination in employment and the provision of government services. DOCR's core programs areas include Equal Employment Opportunity (EEO) initiatives and employee complaint processing; Title VI; Disability; and Disadvantaged Business Enterprise. Director Marion also serves as co-lead of the USDOT-wide Equity Taskforce and is responsible for strategy and implementation across equity initiatives.



Ana Mascareñas

Senior Advisor for Environmental Justice and Climate Change, Office of the Assistant Secretary for Health, U.S. Department of Health and Human Services

Ana Mascareñas serves as senior advisor for environmental justice and climate change to the U.S. Department of Health and Human Services' Assistant Secretary for Health, Admiral Rachel Levine. Ana has dedicated her career to centering equity and justice for marginalized communities within multiple levels of government, and across academic and nonprofit organizations.
