U.S. DOT Connect to Capital is an online portal that serves as an interactive virtual platform for Small Disadvantaged Businesses (SDBs), Disadvantaged Business Enterprises (DBEs) and private capital investors, SBA licensed Small Business Investment Companies (SBICs), U.S. Treasury's State Small Business Credit Initiatives (SSBCIs), and U.S. Treasury's Community Development Financial Institutions (CDFIs).

The purpose of U.S. DOT Connect to Capital is to provide a secure and reliable way for SDBs/DBEs and private investors to interact, build relationships and gain access to capital. Through the platform, the SDBs/DBEs and various private investment industries can match based on profile preferences and connect to discuss access to capital and goals. The platform features virtual tools to enable these interactions such as a virtual library, video instruction guide, webinars, roundtable discussions, and matchmaking.

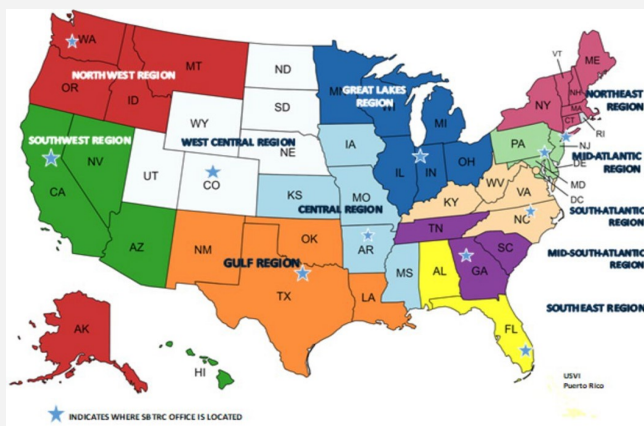

Get to Know our DOT Small Business Specialists



Meet the Office of the Secretary Small Business Specialist



Steven Budd wears many hats in the U.S. Dept. of Transportation's Office of the Secretary (OST), serving as OST's Small Business Specialist (SBS), Acquisition Career Manager (ACM), and as a Contract Specialist. Before joining the DOT team, Steven worked in contracting at the U.S. Army Corps of Engineers (USACE), where he awarded service, supply, and R&D contracts supporting USACE Headquarters. Prior to his time at USACE, he worked for the Defense Logistics Agency's (DLA) Medical Readiness Division, where he procured pharmaceuticals and medical/surgical supplies to support emergency response and contingency requirements. Steven holds a B.S. in Computer Forensics from Bloomberg University and a J.D. from Drexel Law. He practiced as an attorney prior to his career in the federal

government, working in public interest and housing law, criminal defense, and as a contract attorney. In his free time, Steven enjoys the outdoors, traveling, and going out to dance with friends.

What is OST's mission?

OST oversees the formulation of national transportation policy and promotes intermodal transportation. Other responsibilities range from negotiation and implementation of international transportation agreements, assuring the fitness of US airlines, enforcing airline consumer protection regulations, issuance of regulations to prevent alcohol and illegal drug misuse in transportation systems, and preparing transportation legislation.

What are the most common NAICS codes for OST procurements?

541611 – Administrative Management and General Management Consulting Services
561612 – Security Guards and Patrol Services
541511 – Custom Computer Programming Services
485999 – All Other Transit and Ground Passenger Transportation
541519 – Other Computer Related Services

How should small businesses reach out to OST procurement officials and any tips?

We recommend that small businesses first review OST's upcoming requirements on the DOT [Procurement Opportunity Forecast](#) to identify any upcoming needs that may fit the small business' portfolio. Acquisition planning begins with the program office in OST, so the points of contact listed in our forecast opportunities connect you directly with the program office official responsible for the requirement; this is an excellent opportunity to make a mark in the market research being conducted! What are OST's small business achievements from the past fiscal year?

OST has far exceeded all of our small business socioeconomic goals for FY23. OST awarded 50.9% of all its FY23 contracting dollars to small businesses, more than 15 points over our goal of 33.4%. 36% of all OST contracting dollars went to Small Disadvantaged Businesses, also 15 points over our goal of 21%. OST more than doubled our 3% goals for awards to Service-Disabled Veteran-Owned and HUBZone Small Businesses, achieving 6.6% and 6.8%, respectfully. OST is proud to have tripled our 5% goal in FY23 for Women-Owned Small Businesses, awarding 15.6% of our contract dollars to WOSBs.

U.S. DOT Great Lakes SBTRC Small Business Client Secures International Bridge Project Contract



Eze Ejelonu is the President of Best Network Design LLC (BND) founded in 2014. BND is a DBE and MBE firm that specializes in low-voltage electrical contractor and security, telecommunication, Electrical Vehicle (EV) charging, and IT services. Over the past 10 years, Eze has been able to secure millions of dollars in contracts with municipal, state, and federal agencies and even grew his business during COVID-19 pandemic. Some of his most notable contracts have been with the City of Detroit, Wayne County, Detroit Housing Commission, Care First Rehabilitation (Healthcare), and Rallyhouse.

Best Network Design LLC is currently working on a once-in-a-generation infrastructure project: the [Gordie Howe International Bridge](#). This bridge creates the first seamless highway-to-highway connection between Detroit, Michigan and Windsor, Ontario. The infrastructure project currently under construction features a six-lane crossing of the Detroit River connecting the U.S. to Canada to provide much needed transportation improvements for international travel and economic prosperity for both nations. Once completed, the 1.5-mile crossing will also be the longest cable-stayed bridge in North America!

Eze is actively involved in his community. Through his relationship with the [Great Lakes Small Business Transportation Resource Center \(SBTRC\)](#) he has taken advantage of the [U.S. DOT Women & Girls in Transportation Initiative \(WITI\)](#)

which offers young women from universities across the country internship programs to increase the participation of women in the transportation industry. He has previously hosted interns in his firm and is excited to work with another intern this summer on the monumental Gordie Howe International Bridge Project.
