

Federal Transit Administration

- Funds more than 1,000 local public transit systems across the county that run city buses, subways, ADA paratransit, and more
- Invests more than \$20 billion annually to support and expand public transit
- In FY 2023, \$1.1 billion were awarded to DBEs through 4,100 FTA-funded contracts



FTA Office of Civil Rights

Mission

Supports mobility and economic development in America's communities by promoting equitable and accessible public transit through education and industry oversight

Responsibilities

- Oversee FTA recipient compliance with civil rights regulations and programs
- Conduct and support FTA oversight activities
- Develop civil rights guidance and policy
- Provide technical assistance and training
- Advance equity initiatives and equity integration into policies and programs



Disadvantaged Business Enterprise Program

- 49 CFR § 26 prohibits discrimination in DOT-funded contracts by ensuring fair competition for women- and minority-owned businesses bidding and working on DOTfunded contracts
 - Applies to all FTA-assisted contracts unless expressly stated otherwise
 - Does not apply to locally funded contracts
- Seeks to create a level playing field for DBEs
 - Contract/procurement policies that remove barriers for small disadvantaged businesses
 - Does not create quotas

- Notice of Proposed Rulemaking (NPRM) published July 21, 2022
- Final Rule issued April 9, 2024

Final Rule

- Most comprehensive update to the program; intended to streamline and modernize 49 CFR § 26 to reduce barriers for DBEs and clarify requirements for recipients
- FTA's transit-specific provisions improve the program for recipients, TVMs, and DBEs

DBE Program Applicability

Most FTA funds are covered, but not all

- Applies to capital, operations, and planning funds
- Applies with DBE multimodal funds through FTA, FHWA, and FAA, but not other modes
- Tribal Transit is exempt



Why a Tiered Approach?

- Bring more recipients into the DBE program
- Reduce administrative burden on smaller recipients
- Increase data FTA receives for oversight purposes
 - Old rule = no visibility to DBE contracting opportunities among smallest recipients (<\$250,000)
- Use data to inform future policymaking





New FTA Guidance for Tier II Recipients

- FTA issued guidance on April 25, 2024
- Covers how Tier II recipients should implement the five applicable provisions
- Notes Tier II recipients do not need to submit a DBE program plan
- Sets expectation that Tier II recipients "memorialize the policies and procedures needed to ensure compliance with 49 CFR § 26"

Five Provisions for Tier II

FTA Tier II Recipients must maintain a program locally that includes:

1.	Recordkeeping and Reporting Requirements (49 CFR §26.11)
2.	Contract Assurance (49 CFR §26.13)
3.	Policy Statement (49 CFR §26.23)
4.	Small Business Element (49 CFR §26.39)
5.	Transit Vehicle Procurement Requirements (49 CFR §26.49)



Recordkeeping and Reporting Requirements

Uniform Report

- Tier II reporting once per year via TrAMS
 - First report due December 1, 2025, covering FY 2025
 - Uniform Report issued to Tier II recipients in October
- Information Captured
 - Awards/commitments/payments to DBEs and non-DBEs
 - Number and dollar value of contracts
 - Ethnicity and gender of DBE firm owners
 - [NEW] Individual firms, NAICS codes, and work type awarded/committed
 - [NEW] Dollar amount of individual contracts



Recordkeeping and Reporting Requirements

Bidders List

- Captures additional information, including:
 - Firm name and address
 - Firm's age and status as a DBE or non-DBE
 - Race and gender information for the firm's majority owner
 - NAICS code applicable to each scope of work the firm sought to perform in its bid
 - Annual gross receipts of the firm
- DOT will issue guidance on how/when to submit (will not be TrAMS)





Contract Assurance

Use the language verbatim

- FTA-Recipient Agreements, §26.13(a)
- Recipient-Prime Agreements, §26.13(b)

Have a plan to address breaches

 Should develop quality assurance and control mechanisms



Policy Statement

Intended to reflect the DBE program objectives found in 49 CFR §26.1

- Usually 1–2 pages
- Must be circulated among staff
- Must be posted on your website
- Must be emailed to certified DBEs in your state
- Must be signed by chief executive (and should be updated accordingly)





Small Business Element (SBE)

- SBE is a race/gender-neutral component of the DBE program
- Recipients must evaluate procurement practices and identify barriers to small business participation
- Examples of how to address barriers:
 - Set-aside program based on contract \$ amount (e.g., <\$1 million)
 - Requiring primes to specify subcontracting opportunities
 - Structuring contracts so that small businesses can reasonably perform
 - Business development services





Small Business Element (SBE) Continued

- Some Tier II recipients are already meet requirements
 - Post-2015 DBE program should have an SBE
 - You may have a local small business program
- Some Tier II recipients need to develop a SBE from scratch
 - Evaluate your contracting practices
 - Find and address barriers for small business participation
- Tier IIs are not required to submit their SBE for review and approval



Transit Vehicle Procurement Requirements

Specific rules for transit vehicle procurements

- Recipients may only award FTA-assisted contacts to "eligible" DBE-certified TVMs
- TVM must report within 30 days of becoming contractually required to procure a transit vehicle
- Exclude transit vehicle awards from your DBE program
- Eligibility list on FTA's DBE webpage







DBE Program Plan

- Tier II recipients must have written policies to ensure compliance with 49 CFR §26
- Each recipient should review documents related to procurement, and federal compliance to ensure DBE is integrated properly
- Tier II recipients are not required to submit a program plan to FTA for review and approval
- Sample plan in development




Goal Methodology

- Tier II recipients are **not required** to develop and submit to FTA an overall goal unless:
 - A project or contract will have specific goals (race/gender-conscious); OR
 - A one-time project or contract exceeds \$670k
- Recipients are allowed to develop a race/gender-neutral goal without submitting to FTA. Retain:
 - DBE goal and supporting methodology
 - Uniform Report records for the goal period
- Small business element goals are permitted

Additional Part 26 requirements may apply to Tier II recipients using race/gender-conscious programs





Implementation Timeline

- Tier II recipients must implement their DBE programs is October 9, 2024
- Recipients with existing DBE program plans may begin implementing their Tier II program immediately
 - Required to submit Uniform Reports due June 1 and December 1, 2024, and then will submit annually



FTA Oversight

- FTA conducts routine and ad hoc oversight activities:
 - Uniform Report reviews
 - DBE program and goal reviews
 - Compliance reviews (e.g., Triennial Reviews)
 - Complaint investigations
- Failure to implement corrective actions may result in a noncompliance finding and denial of funding






Recipient Frequent Questions

- Q: How do we handle new DBE program submissions due before October 9, 2024?
- Q: Are micro purchases (purchases of less than \$10,000) subject to DBE or exempt from DBE under the new rule?
- Q: Do Tier II recipients still need to submit DBE Uniform reports on June 1, 2024, and December 1, 2024? How have submission deadlines changed under the new rule?
