UPCOMING DATES & DEADLINES

- **Draft Implementation Reports** are due twelve (12) months from grant start date. Thank you to those of you who submitted on July 15th. The next due date for some recipients is August 1st. DIRs should be submitted **as Word Documents** to smartreports@dot.gov. Guidance for the Implementation Report (and the draft) can be found on the [SMART website](#).
- We are **cancelling** the **quarterly milestone progress report #4** due **July 30th** in favor of giving all grantees time to focus on their Draft Implementation Reports. **Federal Financial Report #4 is still due.** The next quarterly milestone report for FY22 and FY23 grantees will be October 30th, for the period ending September 30th. Feel free to report on events from April 1 – Sept 30th, since the previous report was cancelled.

Post-Crash Care Summit: Registration is now open for the August 6 [virtual](#) Post-Crash Care Summit sponsored by the Federal Interagency Committee on Emergency Medical Services (EMS). The goal of the meeting is to identify and describe best practices and promising approaches in post-crash care with collaboration between highway safety
