Subject: Amended Certification Under 1201 of the American Recovery and Reinvestment Act

Dear Mr. Secretary:

Pursuant to Title XII, section 1201 of the American Recovery and Reinvestment Act (P.L. 111-5 (Feb. 17, 2009)) ("ARRA"), I, Michael W. Cruz, M.D., *I Maga'låhen Guahan para pa'go*, Acting Governor of Guam, hereby certify to the Secretary of Transportation that the Territory of Guam will maintain its effort with regard to State funding for the types of projects in DOT "covered programs" funded under the ARRA. The enclosed list of DOT "covered programs" identifies the amount of funds *Guahan* (Guam) plans to expend from *Guahan* (Guam) sources from February 17, 2009 to September 20, 2010, for the types of projects under the DOT "covered programs" funded under the ARRA.

I understand that if *Guahan* (Guam) is unable to maintain the level of funding identified in this list of the types of projects under the DOT "covered programs" funded under the ARRA, *Guahan* (Guam) will thereafter be prohibited by the Secretary of Transportation from receiving additional limitation on obligations for Federal-aid highway and highway safety construction progress that occurs after August 1 for fiscal year 2011.
