**CERTIFICATION UNDER SECTION 1201 OF THE AMERICAN RECOVERY AND
REINVESTMENT ACT:**

Pursuant to Title XII, section 1201 of the American Recovery and Reinvestment Act (Pub. L. 111-5 (Feb. 17, 2009)) (“ARRA”), I, Adrian M. Fenty, Mayor of the District of Columbia, hereby certify to the Secretary of Transportation that the District of Columbia will maintain its effort with regard to State funding for the types of projects in DOT “covered programs” funding under ARRA. The enclosed list of DOT “covered programs” identifies the amount of funds the State plans to expend from State sources from February 17, 2009 to September, 2010, for the types of projects under the DOT “covered programs” funded under ARRA.

I understand that if the District of Columbia is unable to maintain the level of funding identified in this list of the types of projects under the DOT “covered programs” funded under ARRA, the District of Columbia will thereafter be prohibited by the Secretary of Transportation from receiving additional limitation on obligations for Federal-aid highway and highway safety construction programs that occur after August 1 for Fiscal Year 2011.

Transportation Infrastructure Investment

The District of Columbia will maintain its level of local funding for transportation. Further, the District of Columbia, through the District Department of Transportation (DDOT) will fully obligate its FY2009 FHWA funds of approximately \$130 million, excluding American Recovery and Reinvestment Act funds.

From February 17, 2009 through September 30, 2010, the District of Columbia estimates that it will expend \$71.627 million in local funds to match its FHWA program. This is the best information available at this time and is based on prior year expenditures.
