(Pavement Restoration)**

(TIP ID#3215) Title: Resurfacing Streets and Freeways Citywide

Estimated ARRA amount: \$16,675,000.58

Estimated total Cost: \$16,675,000.58

Location: Various locations, city wide

Description of Work: The work consists of resurfacing roadways along various locations, citywide. In areas of existing asphalt concrete surface, the work will consist of pavement milling to a depth of one (1) to two (2) inches, cleaning and routing of deteriorated pavement joint, potholes, patches, etc and filling with sheet asphalt, AC surface Class "C", AC base Class "B". In areas of finished concrete pavement locations, the work includes replacement of defective concrete panels.

Justification: This project is for additional transportation infrastructure investments. As the DC Department of Transportation (DDOT) continues to amend the STIP and TIP to include projects funded by ARRA Transportation funds, the state will submit additional Section 1511 Certifications. This project is federally eligible, has no right of way or design issues and can be bid quickly. The project will allow roadway and other improvements at various locations.

(TIP ID#5308) Title: Neighborhood Streetscape Improvements

Estimated ARRA amount: \$6,170,603.73

Estimated total Cost: \$6,170,603.73

Location: Various locations, city wide

Description of Work: The work consists of installation of new sidewalk or replacement of defective sidewalk along various locations citywide. The sidewalk may be concrete or brick and will be installed per DC Standards. Curb and gutter replacement work may be included if determined necessary by the engineer.

Justification: This project is for additional transportation infrastructure investments. As the DC Department of Transportation (DDOT) continues to amend the STIP and TIP to include projects funded by ARRA Transportation funds, the state will submit additional Section 1511 Certifications. This project is federally eligible, has no right of way or design issues and can be bid quickly. The project will allow sidewalk and other improvements at various locations.
