### ORDER REQUESTING APPLICATIONS

## **Summary**

By this Order, the United States Department of Transportation (the Department) is requesting applications from communities interested in participating in the Community Flexibility Pilot Program in which up to 10 communities may forego their Essential Air Service (EAS) for a period of 10 years in exchange for a grant equal to two years' subsidy. Applications are due within 60 days of this Order's issuance. If the Department receives 10 or fewer applications that are compliant with applicable requirements within the 60-day period, all such applications will be granted. If more than 10 compliant applications are received within 60 days, the Department will treat the program as a competitive grant program: it will cancel this order, will not award grants under this order, and will issue a Notice of Funding Opportunity under 2 CFR 200.203.

The Department will continue to accept applications after the 60 days until the maximum of 10 communities are accepted into the program.

#### **Background**

On December 12, 2003, the President signed into law Vision 100 -- Century of Aviation Reauthorization Act, P.L. 108-176. Section 405 of that Act established, among other things, a Community Flexibility Pilot Program, under which as many as 10 communities whose scheduled services are currently subsidized or eligible for subsidized service under 49 U.S.C. § 41733(c)(1), may obtain a federal grant by agreeing to forgo their subsidized services for a

period of 10 years. 1 By Order 2004-7-19, July 22, 2004, the Department requested applications for the program; however, no applications have ever been submitted to the Department.

### **Request for Applications**

Applications must contain, at a minimum, the amount of the grant being sought and how it will be used. Grant values will be based on subsidy payments made during the most recent 12-month period of continuous EAS service. Applications should also describe the project in sufficient detail, including its potential to impact environmental resources, so the Department can make a preliminary determination as to what level of review will be necessary pursuant to the National Environmental Policy Act, 42 U.S.C. 4321 et seq., (NEPA) and whether other environmental permits, approvals, or consultations may be necessary under other applicable environmental laws or regulations.

The value of each community's grant would be equal to twice the compensation paid to subsidize its service during the most recent 12-month period of continuous subsidized service. The community may use the grant for any project that (a) is eligible for assistance under, and complies with the requirements of, the Airport Improvement Program, (b) is located on airport property, or(c) will improve airport facilities in a way that will enhance their usage for general aviation. The law directs that community applications must contain, at a minimum, (a) a statement of the amount of the grant being sought, and (b) a description of how the grant will be used.

Interested communities should submit a proposal bearing the title "Application under the Community Flexibility Pilot Program," as well as the name of the community and the legal sponsor of the affected airport, to: EAS@dot.gov.<sup>2</sup> In addition, because the document will be published on www.regulations.gov, each page should be formatted to be viewed online.

#### **Department Review of Applications**

If the Department receives 10 or fewer applications within 60 days of this Order's issuance that are compliant with the program's governing statute, the Department will grant all of them. If more than 10 compliant applications are received within 60 days, the Department will treat the program as a competitive grant program: it will cancel this order, will not award grants under this order, and will issue a Notice of Funding Opportunity under 2 CFR 200.203.

The Department must comply with NEPA and any other applicable environmental review requirements<sup>3</sup> prior to the execution of a grant agreement. The community may not obligate or expend any funds (federal, state or private) for final design, construction, or other activities that represent an irretrievable commitment of resources for the project, or commence any part of final

design, construction, or other activities that represent an irretrievable commitment of resources for the project, prior to the execution of a grant agreement.

The community must assist the Department in its compliance with the provisions of NEPA, the Council on Environmental Quality's regulations implementing NEPA (40 CFR parts 1500-1508), the Department's "Procedures for Considering Environmental Impacts" (DOT Order 5610.1C), and any other applicable environmental laws and regulations. As a condition of receiving financial assistance under this program, the community may be required to conduct certain environmental analyses and to prepare and submit to the Department documents required under NEPA and other applicable environmental laws and regulations (including draft environmental assessments and proposed draft and final environmental impact statements).

Each community awarded a grant must execute a grant agreement with the Department before it begins spending funds under a grant award. Applicants should therefore not assume they have received grants, nor obligate or spend local funds prior to receiving and fully executing grant agreements under this program. Funding from this grant may not be used to pay for expenditures made prior to the execution of grant agreements. Communities should also be aware that numerous assurances are required to be made and honored when federal funds are awarded.<sup>4</sup>

If the Department determines that the project proposed in an application is not consistent with the purpose of the Community Flexibility Pilot Program, the Department would not make an award to that applicant.<sup>5</sup>

#### **Availability of Funds**

It is important that communities understand that all grant obligations are subject to the availability of funds.

This Order is issued under authority delegated in 49 CFR 1.25a(b).

### 49 U.S.C. §41745 Community and Regional Choice Programs

- (a) Alternate Essential Air Service Pilot Program.-
- (1) Establishment.-The Secretary of Transportation shall establish an alternate essential air service pilot program in accordance with the requirements of this section.
- (2) Assistance to eligible places.-In carrying out the program, the Secretary, instead of paying compensation to an air carrier to provide essential air service to an eligible place, may provide assistance directly to a unit of local government having jurisdiction over the eligible place or a State within the boundaries of which the eligible place is located.
- (3) Use of assistance.-A unit of local government or State receiving assistance for an eligible place under the program may use the assistance for any of the following purposes:
- (A) To provide assistance to air carriers that will use smaller equipment to provide the service and to consider increasing the frequency of service using such smaller equipment if the Secretary determines that passenger safety would not be compromised by the use of such smaller equipment and if the State or unit of local government waives the minimum service requirements under section 41732(b).
- (B) To provide assistance to an air carrier to provide on-demand air taxi service to and from the eligible place.
- (C) To provide assistance to a person to provide scheduled or on-demand surface transportation to and from the eligible place and an airport in another place.
- (D) In combination with other units of local government in the same region, to provide transportation services to and from all the eligible places in that region at an airport or other transportation center that can serve all the eligible places in that region.
- (E) To purchase aircraft to provide transportation to and from the eligible place or to purchase a fractional share in an aircraft to provide such transportation after the effective date of a rule the Secretary issues relating to fractional ownership.
- (F) To pay for other transportation or related services that the Secretary may permit. (b) Community Flexibility Pilot Program.-
- (1) In general.-The Secretary shall establish a pilot program for not more than 10 eligible places or consortia of units of local government.
- (2) Election.-Under the program, the sponsor of an airport serving an eligible place may elect to forego any essential air service for which compensation is being provided under this subchapter for a 10-year period in exchange for a grant from the Secretary equal in value to twice the compensation paid to provide such service in the most recent 12-month period.
- (3) Grant.-Notwithstanding any other provision of law, the Secretary shall make a grant to each airport sponsor participating in the program for use on any project that-
- (A) is eligible for assistance under chapter 471 and complies with the requirements of that chapter;
  - (B) is located on the airport property; or
- (C) will improve airport facilities in a way that would make such facilities more usable for general aviation
