Statutory Language

 "No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal Financial assistance."





Department of Transportation

Examples Where DOT Could Have Helped

Example

- Limited English Proficient (LEP) individuals use your services
- An African American community is unable to get service
- Service is reduced and eliminated mostly in minority areas

DOT Assistance

- Provide approaches to address LEP responsibilities
- Explain how Title VI protects against disparate impact

Principles for Civil-Rights-Focused Data Analysis

Data Analysis should:

- 1. Support transportation goals
- 2. Tell a story about benefits and burdens for everyone
- 3. Be consistently and effectively applied
- 4. Be easily understood
- 5. Help evaluate the quality of transportation



Data-Driven Vision

- Supporting goals
 - Assess project, programs and services impacts
 - Promote meaningful public engagement
 - To evaluate Title VI compliance & review complaints
- Reaching your Audience
 - Leadership?
 - Stakeholders?
 - Community residents and/or general public?
- Evaluation
 - Are we meeting goals? Do goals have to change?
