Further discussion regarding Tribes being applicable for assumable programs via funding source; grant, set-aside, discretionary, entitlement, formula, etc.? What programs do we need to pursue based upon application? Federal funds administered by the State can be routed to Tribes via 202 (a) (9) agreement. Not all States have the agreement available. (Bob) Use Indian Highway Safety Training Program for a base. Indian Justice Services Award. Title 1 or Title 4. (SK) Flexibility of appropriating funds via SG is the primary objective. Who would be the Governing Body under the proposed SG agenda? Is the goal of the SG session limited to TTP funds or other FED Programs? (DB) SG session vision is not solely for TTP funds, this is why all the FED Representation are present. We do not want to make the same mistakes as the past, we are trying to navigate the platform of the process as quick as possible. SG would be the desired funding mechanism. RFA's will identify funding streams, protocols, etc. we just do not know who will develop these and the process has to be vetted. Internally the FEDS have to discuss and determine the SG Department within their own group for FY2018. Who is going to facilitate the assignments for SG within the FEDS? (Bob) OPS has requested someone from Federal Lands to discuss ROW at the upcoming sessions. (DM)

- J. What rules will apply based upon what Tribes select within each Program? (AC) Who issues regulations per program? What will be the process for non-compliance? (Bob) FAA trying to make sense of what current compliances are applicable to Tribes or assumable to Tribes? Current statute is conflicting as interpreted. (KA) SG Tribes currently do not benefit from all programs and the intent is for the NEG REG to address these gaps. SG Tribes currently do not receive adequate shares of funding. (JP) The BIA and FHWA still has to acknowledge a changing of the guard or mindset to implement the true intent of SG. (SK) What are our true targets based on what is reasonable successful for the OPS workgroup? Maybe we need to focus our efforts towards goals that we actually can achieve, and pertain to the NEG REG origin? Clarification between statute and policy? Statutory concerns are true hurdles that may not achieve any success? (KA) Under Direct FHWA agreement, the procurement is navigated by Tribal Procurement. The Tribal Procurement policy may be submitted to FHWA or the Funding Agency for approval. The Funding Agency may adopt a policy or exception to accept Tribal Procurement policy. (DB)
