Minutes Seventh Meeting of the DOT ACCESS Committee November 2, 2016 Hilton Arlington Hotel, Arlington, VA

The Department of Transportation's Advisory Committee on Accessible Air Transportation (ACCESS) met on November, 2016 in Arlington, Virginia. In accordance with the Negotiated Rulemaking Act, 5 U.S.C. §561-570, and the Federal Advisory Committee Act (FACA), 5 U.S.C. App.2, the meeting was open to the public. Richard Parker, Facilitator, called the meeting to order at 10:30 a.m. on Wednesday, November 2, 2016. The list of individuals attending the meeting is provided by **Attachment 1**. The agenda for the meeting is attached hereto as **Attachment 2**.

Committee Action

The ACCESS Committee convened at 10:30 am after the advocacy and airline groups were given time to caucus and form unified positions. After opening remarks and introductions the committee began its group discussion of the consolidated facilitator's draft proposal.

In-Flight Entertainment and In-Flight Communications Subcommittee.

Discussions began with the timeline for the rollout of a portable electronic device (PED) program. The airline representatives began the discussion with their initial take on the timeline for rolling out a PED program. The airline proposal stated that seatback IFE systems that do not offer at least bitmap captioning on or after 3 years after the Department's final rule, carriers would offer the option of a carrier-supplied PED program or a passenger supplied PED via streaming from an onboard server or wifi. The plenary session broke for the advocates to discuss their reply to the proposed timeline.

The advocates came back to the table with their counterproposal presented by Geoff Freed of the National Center for Accessible Media. The advocates agreed to the 3-year timeline, but proposed a timeline of no longer than 6 months for making updates to the schedule for updating the wifi user interface to make it more accessible to passengers during the transition period. This sparked a lengthy discussion within the Committee as to how long the process of introducing a software update throughout an entire aircraft fleet should take.

After lunch the group separated to caucus and refine their positions on the proposals. The Committee reconvened at 7:15pm to review the progress that had been made on the group proposal. The committee worked together to refine and the wording on the proposal until about 8:30pm when the group was dismissed. A vote on the issues will be taken over a teleconference meeting within the next several weeks.
